Ghansanvagi, Dist. Jalna (Maharashtra)** established by the **Jamia Islamia Ishaatul Uloom, Akkalkuwa, Nandurbar (Maharashtra)** for the Academic Year 2022-23 for 100 intake capacity for B.H.M.S. - 6) This First Time Affiliation for 100 intake capacity for B.H.M.S. (UG) course valid for Academic Year 2022-23 only.
- 7) The next batch of students shall not be admitted unless Continuation of Affiliation of MUHS, is obtained by college / Institute.
- 8) Bank Guarantee should be submitted within a period of 1 month from the date of issuance of this letter to the University.
