

MEMORANDUM OF UNDERSTANDING FOR (MOU) FOR AMBULANCE SERVICES

BETWEEN

Minhajul Uloom Welfare Trust

Hereinafter referred to as "JIIU's Omar Hom"

This Memorandum of Understanding (MOU) is made and entered into on this 2nd day of January, 2025, by and between:



1. Minhajul Uloom Welfare Trust, a registered trust  
Having its office at At. post Ranjani  
Near Railway Station  
Dist. Jalna

Hereinafter referred to as the "Trust"

2. JIU's Omar Homoeopathic Medical College and Research Centre,  
Located at At post Ranjani  
Near Railway station  
Dist. Jalna

Hereinafter referred to as the "College"

The Trust and the College shall collectively be referred to as the "Parties" and individually as a "Party."

### 1. Purpose

The purpose of this MOU is to establish a mutual understanding regarding the use of the ambulance owned by the Trust by the College for medical and emergency services.

### 2. Responsibilities of the Trust

The Trust agrees to:

- a) Provide the access to its ambulance for emergency patient transportation and medical support.
- b) Ensure that the ambulance is maintained in good working condition.
- c) Provide a driver for the ambulance as and when required.
- d) Allow the ambulance to be used for medical camps, student training, and emergency transportation within the scope of the College's activities.

### 3. Responsibilities of the College

The College agrees to:

- a) Use the ambulance strictly for medical and emergency purposes.
- b) Bear the fuel and operational costs incurred during its use.
- c) Ensure that the ambulance is handled responsibly and returned in good condition after use.
- d) Compensate for any damages caused due to negligence during the use of the ambulance.

#### 4. Duration & Termination

- a) This MOU shall be valid for a period of 10 years from the date of signing unless terminated earlier by mutual consent.
- b) Either Party may terminate this MOU by giving a 90 days' prior written notice to the other Party.

#### 5. Indemnity & Liability

The College shall indemnify the Trust against any legal or financial liabilities arising from the use of the ambulance, except for issues related to pre-existing mechanical faults.

#### 6. Miscellaneous

- a) This MOU does not create any legal partnership or employment relationship between the Parties.
- b) Any disputes arising from this MOU shall be resolved through mutual discussion.
- c) Any amendments to this MOU shall be made in writing and signed by both Parties.

#### 7. Signatures
